	249. BULLYING/CYBERBULLYING
1. Purpose	The Board is committed to providing a safe, positive learning environment for district students. The Board recognizes that bullying creates an atmosphere of fear and intimidation, detracts from the safe environment necessary for student learning, presents an obstacle to social/emotional development of students, and may lead to more serious violence. Therefore, the Board prohibits bullying by district students.
2. Definitions SC 1303.1-A	<b>Bullying</b> means an intentional electronic, written, verbal or physical act or series of acts directed at another student or students, which occurs in a school setting and/or outside a school setting, that is severe, persistent or pervasive and has the effect of doing any of the following:
	1. Substantial interference with a student's education.
	2. Creation of a threatening environment.
	3. Substantial disruption of the orderly operation of the school.
	Bullying, as defined in this policy, includes cyberbullying.
	Cyberbullying means an intentional electronic act or a series of acts through the utilization of computers, the internet, interactive and digital technologies, or electronic devices that are directed at another student or students, which occurs in a school setting and/or outside a school setting that is severe, persistent or pervasive and has the effect of doing any of the following:
	<ol> <li>Substantial interference with the student's education;</li> <li>Creation of a threatening environment;</li> <li>Substantial disruption of the orderly operation of the school;</li> <li>Examples of cyberbullying include sending or posting inappropriate or derogatory email messages, instant messages, text messages, digital pictures or images, or website posting (including blogs). All forms of cyberbullying are unacceptable and, to the extent that such actions are disruptive of the educational process of the District, offenders shall be subject to appropriate disciplinary consequences as specified herein.</li> </ol>

	<b>Bullying</b> consists of a pattern of harmful behavior by a person toward another person. This may include a wide variety of behaviors, with deliberate intent to hurt, embarrass, or humiliate the other person.		
SC 1303.1-A	<b>School setting</b> means in the school, on school grounds, in school vehicles, at a designated bus stop or at any activity sponsored, supervised or sanctioned by the school and on the way to and from school.		
3. Authority SC 1303.1-A	The Board prohibits all forms of bullying by district students.		
	The Board encourages students who have been bullied to promptly report such incidents to teachers, the building principal or other adults.		
	The Board directs that complaints of bullying shall be investigated promptly, and corrective action shall be taken when allegations are verified. Confidentiality of all parties shall be maintained, consistent with the district's legal and investigative obligations. No reprisals or retaliation shall occur as a result of good faith reports of bullying.		
	To the greatest extent possible, all complaints shall be treated as confidential, consistent with the District's legal and investigative obligations.		
<ol> <li>Delegation of Responsibility</li> </ol>	Each student and staff member shall be responsible to respect the rights of others and to ensure an atmosphere free from bullying.		
SC 1303.1-A	The Superintendent or designee shall develop administrative regulations to implement this policy.		
SC 1303.1-A	The Superintendent or designee shall ensure that this policy and administrative regulations are reviewed annually with students at an assembly or by other means.		
	The Superintendent or designee, in cooperation with other appropriate administrators, shall review this policy every three (3) years and recommend necessary revisions to the Board.		
	District administration shall annually provide the following information with the Safe School Report:
